### Note from the Chairperson

Welcome to the Annual Report of *Social Justice Ireland*. This report covers the period from July 1, 2013 to August 31, 2014.

The past year has been very busy for us. Exiting the 'bailout' brought a little ray of light to Irish people. It was an opportunity for *Social Justice Ireland* to refocus our policy agenda. While the reduced oversight of the Troika is welcome, most people haven't experienced any improvement in their quality of life. The growth in poverty and inequality in the past year poses a challenge to the common good and the work of social justice.

The Board of *Social Justice Ireland* keeps a strong focus on macro- economic and social policy while ensuring our activities are shaped from the perspective of vulnerable people and communities and are in the service of the common good. A key aspect of our agenda is the development and maintenance of a vision that is energising and achievable. The challenge is to identify and respond to the connections between the international, national and local policy frameworks in a manner that supports good practice and positive outcomes for all people and the environment.

The stance taken by *Social Justice Ireland* is developed by the Board in line with our strategic plan and from the perspective of human dignity, human rights, the common good and sustainability.

During the past year the organisation benefitted from the work and support of:

- o The Academic Advisory Council who ensure that standards are maintained in the areas of research, publications and policy stance.
- o The Budget Team who research and help to prepare the documentation.
- The Finance and Organisational sub-committee who work on sustainability issues e.g, structure, membership, funding and staffing.
- o The Communications Sub-Committee which advises, supports and helps to evaluate our communications strategy.

Appropriate Board time was given to issues of governance. We are happy to confirm that *Social Justice Ireland* is compliant with the Governance Code for the Community, Voluntary and Charitable Sector in Ireland. It has also signed the Statement of Guiding Principles for Fundraising.

An outline of our mission and activities are given in the following pages. You will see that while we have a broad agenda it springs from a focused vision. Evaluation is part of our ongoing processes where great attention is given to outcomes.

A notable feature of our work in the past year has been the growth in our engagement at international level (e.g. monitoring EU2020 Strategy, EU Crisis Monitoring Report covering seven

countries, presentations at international events) and at local level in Ireland (e.g. developing Public Participation Networks at Local Authority level, promoting civil society organisations' capacity for policy engagement). A further notable feature has been the development of a new initiative and publication: Ireland's *National Social Monitor*.

During the coming year we will be developing a new strategic plan. A sub-committee of the Board has been appointed to facilitate this process. They will be consulting you, our members, about the scope, direction and content of the plan. This is a special moment to review the past five years and shape the future of *Social Justice Ireland*.

We are particularly grateful to Board members and the members of the groups listed above who give generously of their time and expertise to enhance the work of *Social Justice Ireland*. They have been a great support to our staff who have put quality time into the work of the organisation. The following pages attest to the large volume of work done by *Social Justice Ireland*. Much of this work is done on a pro bono basis by the Staff, Board, Committee members and volunteers.

We are grateful to you, members of *Social Justice Ireland*. Your support, both financial and moral is very encouraging and energising.

# e) Government Working Group on Citizen Engagement with Local Government.

- Seán Healy chaired a Working Group established by the Department of Environment, Community and Local Government to make recommendations on more extensive and diverse input by citizens into decision-making processes at the local government level. The Group completed its work on target. The Minister accepted the Report with minor changes. The guidelines for the establishment of People's Participation Networks in every Municipal Area and Local Authority throughout the country have been published. Work is progressing at varying speeds to implement the Report.
- Social Justice Ireland in partnership with the Environmental Pillar hosted twelve public seminars around the country to outline the content of the Report.

#### **Minutes**

# 1. Opening

The meeting was chaired by Finbarr Tracey, Chairperson of *Social Justice Ireland*. Finbarr welcomed the 20 members present to the Annual General Meeting of *Social Justice Ireland*.

# 2. Minutes of the 2012 AGM Meeting

Micheál Collins proposed the adoption of the minutes of the last meeting. This was seconded by Michael Howlett.

# 3. Adoption of Annual Report

Copies of the annual report were circulated. The Chairperson, Finbarr Tracey introduced the report and highlighted the structural development of *Social Justice Ireland* during the previous year. Seán Healy presented an outline of the report. He highlighted the mission of the organisation and the three programmes designed to implement this mission. Muiris O'Connor proposed the adoption of the Report. It was seconded by Justin Kilcullen.

#### 4. Adoption of the Financial Report

Brigid Reynolds presented the financial report which had been circulated to members. She noted the large volume of work that had been done pro bono by Board members and others. The Financial Report was adopted unanimously by the members.

#### 5. Elections

Five members were nominated to fill the five vacancies on the Board. The following were returned unopposed; Sara Bourke, Justin Kilcullen, Sandra O'Hara, Finbarr Tracey, Seán Ward.

- **6.** The Chairperson invited comments from members. The following points were noted
  - Members expressed "amazement at the quality and volume of work done" given the size of the staff.
  - Members put on record their appreciation and support of the stance taken by *Social Justice Ireland* on the various issues addressed in the report.
  - The significant public impact of the work of *Social Justice Ireland* was noted with acclaim.
  - The work done on strategic partnerships was seen as particularly welcome and members wished the partnerships well in the coming year.
  - The large volume of unpaid work done by members of the Board and Staff was applauded. Also the commitment of the Board and Staff to the mission of *Social Justice Ireland* was much appreciated.

#### Mission

Social Justice Ireland advances the lives of people and communities through providing independent social analysis and effective policy development to create a sustainable future for every member of society and for societies as a whole.

- Social Justice Ireland works to ensure that every member of society, and society as a whole, can flourish and thrive in a sustainable manner. We have a special concern for those who are vulnerable or on the margins of society. We believe that the dignity of all is enhanced when those on the margins of society are included. Consequently we promote the development of an inclusive society in which everyone's rights and responsibilities are recognised and honoured.
- We work both nationally and internationally. The inter-relatedness of the local and the global requires that issues be addressed at different levels to ensure appropriate solutions are identified and implemented. We bring this perspective to bear on all we do.

#### **Values**

Social Justice Ireland promotes the values of both human dignity and the centrality of the community. The person is seen as growing and developing in a context that includes other people and the environment. Justice is understood in terms of right relationships. A just society is one that is structured in such a way as to promote right relationships so that human rights are respected, human dignity is protected, human development is facilitated and the environment is respected and protected.

*Social Justice Ireland* speaks for those who have no voice in policy debates. We place a very high value on integrity in all we do and are confident enough to take an uncommon point of view or to propose an unpopular solution.
