Note from the Chairperson

Welcome to the Annual Report of *Social Justice Ireland*. This report covers the period from September 1, 2016 to August 31, 2017.

It has been a very interesting year for *Social Justice Ireland*. The fallout from Brexit, the election of Donald Trump and, domestically, the escalating housing crisis has raised anxiety and insecurity for many people. Ireland is at the centre of a global shift of ideas, values and politics. The rise in populism, fake news and the 'post-truth' society presents *Social Justice Ireland* with many challenges and opportunities. In this climate, facts, analyses, and evidence based research are low in popular demand. However, they are more needed now than ever before and it is imperative that we work to make a space for them. We want to contribute to shaping an Ireland that is based on truth, equality, justice and compassion. Here lie the challenges and the opportunities.

The Board of *Social Justice Ireland* keeps a strong focus on macro-economic and social policy while ensuring our activities are shaped from the perspective of vulnerable people and communities and are in the service of the common good. A key aspect of our agenda is the development and maintenance of a vision that is energising and achievable. The challenge is to identify and respond to the connections between the international, national and local policy frameworks in a manner that supports good practice and positive outcomes for all people and the environment. We focus on tackling the causes of problems, providing evidence based research and offering solutions. In the past year our research and proposals for alternatives in policy development have been greatly sought after, especially by policy makers

The stance taken by *Social Justice Ireland* is developed by the Board in line with our Strategic Plan (2016-2020) and from the perspective of human dignity, human rights, the common good and sustainability. The theme chosen for the year was *A New Social Contract for a New Century.*

During the past year the organisation benefitted from the work and support of:

- The Academic Advisory Council who ensure that standards are maintained in the areas of research, publications and policy stance.
- o The Budget Team who research and help to prepare the documentation.
- The Board Audit and Organisation sub-committee who work on sustainability issues e.g., structure, membership, funding and staffing.
- o The Communications Sub-Committee which develops, supports and helps to evaluate our communications strategy.

An outline of our mission and activities are given in the following pages. You will see that while we have a broad agenda it springs from a focused vision. Evaluation is part of our ongoing processes where great attention is given to outcomes. You will notice that *Social Justice Ireland* maintains a strong international involvement contributing to Caritas Europa's annual study on the Europe 2020 Strategy and also publishing a study of the socio-economic situation in the 28 EU member states. This work was recognised by the United Nations and an invitation was received to present a paper at a United Nations Expert Working Group in New York on the subject: *Strategies to tackle poverty and create decent employment in the EU*.

Local and regional issues are an important part of our agenda. Four years ago, *Social Justice Ireland* put significant resources into the design and establishment of the Public Participation Networks (PPNs). This commitment has continued in our encouragement, training and support of the PPNs.

Appropriate Board time was given to issues of governance. Our Constitution has been revised and accepted by the Revenue Commissioners to comply with recent changes in company law. We are happy to confirm that *Social Justice Ireland* is compliant with the Governance Code for the Community, Voluntary and Charitable Sector in Ireland. It has also signed the Statement of Guiding Principles for Fundraising. We have uploaded the documentation as required by the Charities Regulatory Authority before the assigned target date. We have ensured that the Lobbying Register has been updated on a regular basis.

Deep gratitude is due to Board members and the members of the groups listed above who give generously of their time and expertise to enhance the work of *Social Justice Ireland*. They have been a great support to our staff who have put quality time into the work of the organisation. The following pages attest to the large volume of work done by *Social Justice Ireland*. Much of this work is done on a pro bono basis by the Staff, Board, Committee members and volunteers.

Thank you, members of *Social Justice Ireland*. Your support, both financial and moral is very encouraging and energising.

United Nations

Seán was invited to present a paper at a United Nations Expert Working Group in New York on the subject: *Strategies to tackle poverty and create decent employment in the EU*. The 'Key Policy Messages and Recommendations' document produced by this international group of experts includes the following paragraph:

The social welfare systems in developed countries are no longer fit for purpose. There should be an adjustment of the paradigm including promotion, and openness to study new ideas around a new social contract that is more appropriate for the 21st century. This may entail moving towards a universal basic income system, supporting a living wage rather than a minimum wage, recognizing all work (not just paid employment) as meaningful, and ensuring that all government decisions are subjected to a poverty-proofing process. While the centrality of employment and decent jobs to eradicate poverty is well recognized, employment growth has not been sufficient to absorb the growing labour force, particularly in those countries and regions with large youth populations. Further, there has been a divergence between productivity and wages growth, as well as growing employment insecurity and casualization in all countries.

Global Goals Week As part of Global Goals Week *Social Justice Ireland* published ten 2-page briefings on how Ireland is performing in relation to ten of the seventeen global goals.

Global Justice Conference

To mark World Day of Social Justice (February 20) we organised a seminar on how Ireland is performing on the Sustainable Development Goals. Prof Charles Clark and Dr Catherine Kavanagh who have helped us develop a new index to measure progress on the goals, presented their work. The work was well received by the 80 participants and provoked an energetic discussion. It is planned to update this work annually.

Seán Healy was elected as one of the three representatives of the Community and Voluntary Pillar to the newly re-constituted National Economic and Social Council (NESC).

b) Public Participation Networks (PPNs)

Public Participation Networks bring together environmental, social inclusion, community and voluntary organisations in a city or county to participate in decision making, share information and build mutual capacity. *Social Justice Ireland* sees the successful development of the PPNs as important to ensure that people have a say in the decisions that affect them. To this end, we have been supporting the local volunteers and workers in the PPNs over the past year. Seán Healy sits on the PPN Advisory Committee which advises Government on the future development of PPNs. During the year, PPNs have developed considerably, and have become established in their areas. Their training needs have moved from dealing with administrative issues to dealing with policy. We consider that we have contributed significantly to this development via our PPN supports which included:

 Supporting networking and peer learning among PPNs by hosting 10 regional meetings all over the country which were attended by over 170 representatives from 28 PPNs. Following these regional meetings, we produced a report on the key achievements and challenges to date for PPNs, which was circulated to attendees and the Department. Several of the items raised have been addressed.

- Offering an updated suite of free Development and Support Programmes to PPNs, delivering 16 bespoke training sessions, mainly on policy issues;
- Mentoring PPN volunteers and workers via telephone and email support on a wide range of individual issues.
- Training Local Authorities in maximising the benefit of the PPN including for LA staff, senior management, CEOs and elected councillors;
- Contributing to a number of consultations relevant to the PPNs, and meeting with the relevant Department officials four times.
- Collaborating with the Environmental Pillar on the DEAR project as it relates to PPNs.
- Developing a toolkit to measure and promote community
 well-being which can be used by PPNs. This work has involved working closely
 with the Department of Housing, Planning, and Local Government, the
 Department of Rural and Community Development, the Environmental
 Protection Agency and the Environmental Pillar.
- Co-organising and leading a one-day seminar of the reference group for this Well-being programme.

c) MA in Social Justice & Public Policy

We finalised plans for the MA in Social Justice & Public Policy with the Waterford Institute of Technology. This two-year part-time programme will recommence in September 2018 and will be run out of Dublin.

d) Trocaire

We implemented the agreed programme of work for Trocaire which included input to two Trocaire Conferences; Research on Overseas Development Aid and Research on divestment from fossils fuels.

e) Alone

Renewed our strategic partnership with ALONE for another year. This includes membership of oversight committees; strategic planning; facilitating an engagement between ALONE and the HSE re policies for older people; advising ALONE on research, communications and political engagement.

f) Irish Heart Foundation (IHF)

We made a submission to the Department of Finance as part of the Sugar Sweetened Drinks Tax consultation based on our joint paper with Irish Heart Foundation.

g) Living Wage Group

We continued our involvement with this group which sets the rate for the Living Wage each year.

Social Justice Ireland engaged with the media, print and electronic, so as to promote the outcomes we sought in the various issues raised. In the past year we are aware of the following coverage in the media:

Evaluation, Impacts and Outcomes

Evaluation is an ongoing process where great attention is given to outcomes and impacts. It is carried out in the following phases:

- The weekly staff meetings where specific projects are reviewed in relation to inputs and outputs. The short-term impacts and outcomes (both planned and unexpected) are assessed. The learnings are noted.
- The annual 'think-in' by the staff provides an opportunity to reflect on these learnings and the medium-term outcomes when planning the following year's work.
- At its regular meetings, the Board reviews the report by the staff on outcomes and impacts of recent and current activities.
- A thoughtful and well-focused preparation ensures that the annual think-in by the Board gives space for medium to long-term evaluation of outcomes and impacts.

Proposals for the Future

The work of Social Justice Ireland for the next three years will be in the service of the Strategic Plan 2016-2020 as amended by the Board at its annual think-in.

Mission and Values

Minutes of the Annual General Meeting 2016

Held in Croke Park, Dublin, on Tuesday November 22, 2016 @ 5.00pm

Minutes

1. Opening

The meeting was chaired by Tony Fahey, Chairperson of the Academic Council of *Social Justice Ireland*. Tony welcomed the 12 members present to the Annual General Meeting of *Social Justice Ireland*.

2. Minutes of the 2015 AGM Meeting

Brid Ryan proposed the adoption of the minutes of the last meeting. This was seconded by Margaret Hassett.

3. Adoption of Annual Report

Copies of the annual report were circulated. The Chairperson, Tony Fahey introduced the report. Seán Healy presented an outline of the report under the three programmes. The staff was thanked for their commitment and professionalism.

4. Adoption of the Financial Report

Brigid Reynolds presented the financial report which had been circulated to members. She drew attention to the deficit of €75Kand and the causes for the deficit. She noted the work being done to balance the books in future years. The Financial Report was adopted unanimously by the members.

5. Elections

Five members were nominated to fill the five vacancies on the Board. The following were returned unopposed; Joe Egan, Justin Kilcullen, Sandra O'Hara, Finbarr Tracey and Seán Ward.
