Note from the Chairperson

Welcome to the Annual Report of *Social Justice Ireland.* This report covers the period from September1, 2017 to August 31, 2018

During the past year we in *Social Justice Ireland* were very aware that we were approaching the tenth anniversary of the economic crash that plunged Ireland into austerity, with the consequent record levels of unemployment, homelessness and emigration. Recent years also saw us emerging into a period of tenuous prosperity overshadowed by global instability. Our national experience of unprecedented 'weather events' together with the various international reports on climate change present us with many challenges in a time of rising populism, fake news and the 'post-truth' society. In this climate, facts, analyses, and evidence-based research are low in popular demand. However, they are needed more now than ever before and it is imperative that we work to make a space for them. We want to contribute to shaping an Ireland that is based on truth, equality, justice, compassion, solidarity and sustainability. Here lie the challenges and the opportunities.

The Board and staff of *Social Justice Ireland* keeps a strong focus on macro-economic and social policy while ensuring our activities are shaped from the perspective of vulnerable people and communities and are in the service of the common good. A key aspect of our agenda is the development and maintenance of a vision that is energising and achievable. The challenge is to identify and respond to the connections between the international, national and local policy frameworks in a manner that supports good practice and positive outcomes for all people and the environment. We focus on tackling the causes of problems, providing evidence-based research and offering solutions. In the past year our research and proposals for alternatives in policy development have been greatly sought after, especially by policymakers who are approaching us to engage on a range of key policy areas.

The stance taken by *Social Justice Ireland* is developed by the Board in line with our Strategic Plan (2016-2020) and from the perspective of human dignity, human rights, the common good and sustainability. This is a dynamic document, robust enough to provide a strategy for the years ahead, while also providing room to respond to a rapidly changing environment. The Board marked the mid-way point on this plan by reviewing and updating it. The theme chosen for the year was *Social Justice Matters*.

During the past year the organisation benefitted from the work and support of:

- The Academic Advisory Council who ensure that standards are maintained in the areas of research, publications and policy stance.
- The Budget Team who research and help to prepare the pre- and post-Budget documentation.
- The Board Audit and Organisation sub-committee who work on sustainability issues e.g, structure, membership, funding and staffing.

• The Communications Sub-Committee which develops, supports and helps to evaluate our communications strategy.

In October 2017 *Social Justice Ireland* was very honoured to accept an award from Fiscal.ie (formerly the Foundation for Fiscal Studies). Fiscal.ie said the award was being made to *Social Justice Ireland* in recognition of our "outstanding work". The award was made as part of the annual Fiscal.ie announcement of the Miriam Hederman O'Brien Award. The particular piece of work was the Social Policy Book of 2016 entitled *Basic Income: Radical Utopia or Practical Solution?* On behalf of the Board and Membership, I congratulate the staff on this achievement.

An outline of our mission and activities are given in the following pages. Evaluation is part of our ongoing processes where attention is given to outcomes. You will notice that *Social Justice Ireland* maintains a strong international involvement contributing to Caritas Europa's annual study on the Europe 2020 Strategy and also publishing a study of the socio-economic situation in the 28 EU member states. We have also invested significant resources into research, publications and advocacy on the Sustainable Development Goals.

Local and regional issues are an important part of our agenda. Five years ago, *Social Justice Ireland* put significant resources into the design and establishment of the Public Participation Networks (PPNs). This commitment has continued in our encouragement, training and support of the PPNs, as well as our participation on the PPN National Advisory Group.

Appropriate Board time was given to issues of governance. The big issue this year was the General Data Protection Regulation (GDPR). A member of staff who is skilled in this area was tasked with ensuring all our systems are GDPR compliant. We are happy to confirm that *Social Justice Ireland* is compliant with the Governance Code for the Community, Voluntary and Charitable Sector in Ireland. It has also signed the Statement of Guiding Principles for Fundraising. All required documentation has been supplied to the Charities Regulatory Authority and we have made all necessary submissions to the Lobbying Register.

Deep gratitude is due to Board members and the members of the groups listed above who give generously of their time and expertise to enhance the work of *Social Justice Ireland*. They have been a great support to our staff who have put quality time into the work of the organisation. The following pages attest to the large volume of work done by *Social Justice Ireland*. While paid staff produce much of this work, we are also fortunate enough to avail of the pro bono services of Board members, Committee members and volunteers who have particular expertise.

Thank you, members of *Social Justice Ireland*. Your support, both financial and moral is very encouraging and energising.

Prof Clark, Dr Kavanagh and Niamh Linehan prepared the research entitled *Measuring Progress: Economy, Society and Environment in Ireland* on the Goals. This shows how Ireland is doing over time and how the EU-15 are ranged vis-a-vis each other.
- The event was over-subscribed we closed registration at 107 participants from many fields of interest.
- The conference was live-streamed by Kairos and attracted a big audience.
- The outline of the study and its methodology were presented in Brussels to a meeting of organisations linked to the European Environmental Bureau and their project on SDGs.
- A further study of the progress of the EU28 countries was also published.
- Two further pieces of research were completed on inequality:
 - A 4-page Policy Briefing on Inequality.
 - A 34-page analysis titled Reflections on Inequality in Ireland.

- With the help of Kairos Communications, the conference was livestreamed on YouTube on our website. These presentations are now available online.
- The cartoonist who sketched each paper as it was being presented was much appreciated. His work is also available now on our website.
- We published the papers as a book entitled *Society Matters: Reconnecting People and the State* on the day of the conference.

Budget 2018

b) Public Participation Networks (PPNs)

Social Justice Ireland continues to play a major role in the development of PPNs across the country. We have continued and expanded our on-going training programme and also held a series of regional meetings in the Spring and the Autumn. There are now more than 12,800 local organisations who are members of PPNs. There are more than 800 representatives on local boards and committees and PPNs are now moving towards greater participation in the decision-making structures and processes at local level all over the country. In its work with PPNs during the past year *Social Justice Ireland* also:

- Collected the information for, and produced, the Annual Report 2017 on the PPNs.
- Worked with the Irish Environmental Network to develop a practical toolkit and methodology to support PPNs to develop a Vision for Community Wellbeing to guide their work.
- Supported the DEAR project in their engagement with PPNs regarding the SDGs.
- Met with the Department of Community and Rural Affairs regarding PPNs.
- Presented 15 training sessions for PPN members in 6 venues around the country.
- Facilitated a number of Regional Meetings.
- Seán Healy is the Social Exclusion representative on the PPN National Advisory Group.

c) MA in Social Justice & Public Policy

We finalised plans for the MA in Social Justice & Public Policy with the Waterford Institute of Technology and began the process of recruiting students for the September 2018 commencement of this two-year programme.

d) Trocaire

We implemented the agreed programme of work for Trocaire which included input and Research on Overseas Development Aid.

e) Alone

Renewed our strategic partnership with ALONE for another year. This includes membership of oversight committees; strategic planning; advising ALONE on research, communications and political engagement.

We continued our involvement with this group which sets the rate for the Living Wage each year.

Evaluation, Impacts and Outcomes

Evaluation is an ongoing process where great attention is given to outcomes and impacts. It is carried out in the following phases:

- The weekly staff meetings where specific projects are reviewed in relation to inputs, outputs and impacts. The short-term impacts and outcomes (both planned and unexpected) are assessed. The learnings are noted.
- The annual 'think-in' by the staff provides an opportunity to reflect on these learnings and the medium-term outcomes when planning the following year's work.
- The sub-committees of the Board monitor the activities within their areas of interest.
- At its regular meetings, the Board reviews the report by the staff on outcomes and impacts of recent and current activities.
- A thoughtful and well-focused preparation ensures that the annual think-in by the Board gives space for medium to long-term evaluation of outcomes and impacts.

Proposals for the Future

The work of Social Justice Ireland for the next two years will be in the service of the Strategic Plan 2016-2020 as amended by the Board at its annual think-in.

Mission and Values

- *Social Justice Ireland* works to ensure that every member of society, and society as a whole, can flourish and thrive in a sustainable manner. We have a special concern for those who are vulnerable or on the margins of society. We believe that the dignity of all is enhanced when those on the margins of society are included. Consequently, we promote the development of an inclusive society in which everyone's rights and responsibilities are recognised and honoured.

Values

1. Opening

The meeting was chaired by Justin Kilcullen, Chairperson of *Social Justice Ireland*. Justin welcomed the 18 members present to the Annual General Meeting of *Social Justice Ireland*.

2. Minutes of the 2015 AGM Meeting
