## Note from the Chairperson

Welcome to the Annual Report of *Social Justice Ireland*. This report covers the period from September 1, 2018 to August 31, 2019

Those 12 months were dominated, from a political perspective, by two issues: Climate and Brexit.

One of these is very welcome. *Social Justice Ireland* has long been at the forefront of campaigns that promote environmental sustainability and climate justice. Many of our publications, including our annual *Sustainable Progress Index*, have repeatedly criticised Ireland's performance in relation to our environmental goals. 2019 seems to have been the year when much of society – and as a consequence, Government – has caught up with just how important it is that Ireland improves its performance and becomes a leader, not a laggard, in relation to our climate-related targets.

Brexit's continued dominance of the political agenda is far less welcome, and as a confused stalemate persisted in Westminster for much of the last year, the Irish Government sought to use Brexit as this year's excuse for not doing what is needed to protect vulnerable people and move Ireland in the direction of becoming a more fair, more just society. In the name of "fiscal prudence" and "caution", Budget 2020 contained few policy measures that will have a notable effect on the main crises faced by Ireland, including those in the areas of poverty, housing and homelessness, healthcare, balanced development, transport, and precarious and low paid work.

*Social Justice Ireland* continues to use evidence-based policy solutions and top-class research to counter the prevailing narratives about what is possible and what is desirable in this country, At this time of fake-news and rising political populism, facts, analysis, and evidence-based research are needed more than ever before. They will remain imperative as we look to shape a society based on fairness, equality, solidarity, compassion and sustainability.

The stance taken and work programme of *Social Justice Ireland* were developed by the Board in line with our Strategic Plan (2016-2020). The theme chosen for the year was sustainability. The Board is currently working on our new Strategic Plan for 2021-2025. It is important that all our members have an opportunity to participate in this important phase in the life of our organisation. In spring we will harvest the insights, views and suggestions of members through a consultation process. Having worked through this material it is planned that the Board will launch the New Strategic Plan at the AGM 2020.

During the past year the organisation benefitted from the work and support of:

- The Academic Advisory Council, the members of which help ensure that standards are maintained in the areas of research, publications and policy stance.
- The Budget Analysis Team, whose assistance in helping us provide the first full and comprehensive analysis of the Government's annual budget within 24 hours of its release is invaluable.

- The Board Audit and Organisation sub-committee, who work on issues related to funding, staffing and membership, compliance and other governance issues.
- The Communications Sub-Committee which develops, supports and helps to evaluate our communications strategy.

An outline of our mission and activities are given in the following pages. Evaluation is part of our ongoing processes where attention is given to outcomes. *Social Justice Ireland* continues to maintain a strong international involvement, contributing to Caritas Europa's annual study on the Europe 2020 Strategy, and also publishing a study of the socio-economic situation in the 28 EU member states. We have invested significant resources into research, publications and advocacy on the Sustainable Development Goals, including the production of a *Sustainable Progress Index*.

Local and regional issues remain an important part of our work, and our association with the Public Participation Networks (PPNs) remains strong. Having been central to their formation, we continue to provide support and training to the PPNs on a regular basis. We work on the Government National Advisory group and the review of the PPN Handbook.

Appropriate Board time was given to issues of governance. We are happy to confirm that *Social Justice Ireland* is compliant with the Governance Code for the Community, Voluntary and Charitable Sector in Ireland. We have also committed to compliance with the *Guidelines for Charitable Organisations on Fundraising from the Public* as developed by the Charities Regulatory Authority. All the supporting compliance documentation is available on our website www.socialjustice.ie/about us/join. We update the Lobbying Register as required and are GDPR compliant.

Deep gratitude is due to Board members and the members of the groups listed above who give generously of their time and expertise to enhance the work of *Social Justice Ireland*. They have been a great support to our staff who have put quality time into the work of the organisation. The following pages attest to the large volume of work done by *Social Justice Ireland*. Much of this work is done on a pro bono basis by the Staff, Board, Committee members and volunteers.

Thank you, members of *Social Justice Ireland*. Your support, both financial and moral is very encouraging and energising.

- The event which was over-subscribed was live streamed by Kairos.

#### Social Policy Conference 2018

- The theme of the Conference was *From Here to Where?* Ten years on from the recession it explored the challenges and possibilities for the future.
- The attendance was about 100 and representative of the various interests including policymakers, academics, media, arts, students and community activists.
- The keynote speakers and the young contributors added an extra buzz to the day.

- Participation and feedback were good and provided insightful pointers for future conferences.
- With the help of Kairos Communications, the conference was live-streamed on YouTube and on our website. These are now available online.
- The cartoonist, Philip Barrett, who sketched each paper as it was being presented was much appreciated. His work is also available now on our website.
- Media coverage was a bit disappointing. However, the op-ed pieces were very useful in getting the message out. Of particular note was Tony Fahey's op-ed in the Journal online which was the most-read article on the site for two days.
- We published the papers as a book entitled *From Here to Where? Negotiating a Better and Fairer Future* on the day of the conference.

#### Budget 2019

- Three publications were prepared:

## b) Public Participation Networks (PPNs)

We continued to engage with the Department of Rural and Community Development and PPNs to support the development of the Public Participation Networks. This work included:

## c) MA in Social Justice & Public Policy

- The first group of students taking the MA in Social Justice and Public Policy from Waterford Institute of Technology (WIT) began their two-year part-time programme in September 2018. This programme is similar to that run for ten years in All Hallows College (accredited by DCU) but had to be terminated when the college closed.
- The partnership with WIT is very satisfactory.
- The programme is taught in the Carmelite Centre in Aungier Street, Dublin
- We lectured on three of the modules and contributed to the joint coordination of the programme.

## d) Trocaire

- We implemented the agreed programme of work for Trocaire which included input and Research on Overseas Development Aid.
- In preparation for the European Elections *Social Justice Ireland* and Trocaire organised a Hustings in Dublin Castle.
- All the invited candidates accepted our invitation to present their positions on 5 'Asks'.
- About 60 people participated in the session, which was chaired by journalist, Michael Clifford.

## e) ALONE

• *Social Justice Ireland* has worked with ALONE for several years to support their policy development and political lobbying. SJI supports ALONE by drafting policy statements and papers, fact checking and verifying their statistics, and advising on ALONE's policy position in relation to all areas, including housing, home care, equality and social protection. SJI played a key role in writing and verifying ALONE's Housing Choices for Older People: Time for Action report released last year.

## f) DEAR Project

- Continued work as part of this project. Of particular interest is our Sustainable Progress Index publication which plays a key role in promoting the Sustainable Development Goals which are at the core of this project.
- The project's annual conference examined the role of small-scale farmers and food producers in achieving the Sustainable Development Goals. We presented a paper on Ireland and the SDGs with a particular focus on those relating to rood production and rural development.
- We also produced a 2-page Policy Briefing setting out how Local Authorities could take action towards implementing all 17 SDGs.

## g) Living Wage Group

  - Over 85 stories in the **National** press including 10 editorials and 22 op-ed pieces.
  - 96 online newspaper articles.
  - We are aware of a number of articles in the **Local press** but don't have the resources to track them.

• Our combined social media footprint is now 20,699 up from 17,877 (+15.7%) in the past year

## **Evaluation, Impacts and Outcomes**

Evaluation is an ongoing process where great attention is given to outcomes and impacts. It is carried out in the following phases:

- The weekly staff meetings where specific projects are reviewed in relation to inputs and outputs. The short-term impacts and outcomes (both planned and unexpected) are assessed. The learnings are noted.
- The annual 'think-in' by the staff provides an opportunity to reflect on these learnings and the medium-term outcomes when planning the following year's work.
- The sub-committees of the Board monitor the activities within their areas of interest.
- At its regular meetings, the Board reviews the report by the staff on outcomes and impacts of recent and current activities.
- A thoughtful and well-focused preparation ensures that the annual think-in by the Board gives space for medium to long-term evaluation of outcomes and impacts.

## **Mission and Values**

*Social Justice Ireland* advances the lives of people and communities through providing independent social analysis and effective policy development to create a sustainable future for every member of society and for societies as a whole.

- We advance the lives of people and communities by working to build a just society. In doing this we give special priority to national and international issues related to poverty, inequality, social exclusion, sustainability and the environment.
- As an independent think tank *Social Justice Ireland* is a significant research resource in the area of social justice and public policy. We provide accurate social analysis of the current situation on an ongoing basis and identify effective policy proposals to address challenges.
- We are one of the leading advocates for the changes needed for a future that is sustainable economically, environmentally and socially. We identify credible alternatives and effective pathways to resolving challenges faced across a wide range of public policy.
- *Social Justice Ireland* works to ensure that every member of society, and society as a whole, can flourish and thrive in a sustainable manner. We have a special concern for those who are vulnerable or on the margins of society. We believe that the dignity of all is enhanced when those on the margins of society are included. Consequently, we promote the development of an inclusive society in which everyone's rights and responsibilities are recognised and honoured.
- We work both nationally and internationally. The inter-relatedness of the local and the global requires that issues be addressed at different levels to ensure appropriate solutions are identified and implemented. We bring this perspective to bear on all we do.

## Values

*Social Justice Ireland* promotes the values of both human dignity and the centrality of the community. The person is seen as growing and developing in a context that includes other people and the environment. Justice is understood in terms of right relationships.
